Kenneth M. Yamada, MD, PhD

Chief, Laboratory of Cell & Developmental Biology *Head,* Cell Biology Section, NIH/NIDCR

Dr. Yamada's research focuses on mechanisms of cell adhesion, migration, and interactions with the extracellular matrix in embryonic development and tumor cell invasion.

He has been honored with election as a fellow of the American Association for the Advancement of Science, the Senior Investigator Award for the American Society for Matrix Biology, and the Distinguished Scientist Award of the American Association for Dental Research. He has served on the Councils of the American Society for Cell Biology, International Society for Matrix Biology, American Society for Matrix Biology, and NIH Assembly of Scientists. Dr. Yamada is an editor of The Journal of Cell Biology and is a board member/associate editor of a number of journals, has published more than 400 papers and reviews, and is currently an Institute for Scientific Information "Highly Cited Researcher." He served a full term on the NIH Cell Biology Study Section and is on the NIH Steering Group for the Dentistry and Oral Health Sciences Section of the American Association for the Advancement of Science.

He chaired the AADR Outreach Program in Cincinnati and Boston and has been course

director and mentor to more than 130 students, many of whom have gone on to careers in science. Dr. Taubman has served as President of AADR, Distinguished Faculty Award, HSDM, NIH Merit Award, International Association of Dental Research, Research in Oral Biology Award, and IADR Distinguished Scientist Award for Basic Research
